Participant Input for Management and Maintenance of INF Recreation Access

How to Read the Input on the Following Pages

After an opening presentation by the Inyo National Forest Public Affairs Specialist and facilitated dialogue about the meaning and importance of "*Recreation*" on the national forest, participants at the June Lake (October 30) and Big Pine (October 28) Gateway Communities workshop were invited to gather around map tables. Each map table provided a "snapshot" visual map of recreation access points and symbols associated with each Gateway Community.

Participants were asked to review each map and consider their own experience of the recreation areas indicated by access points and symbols on the map. They were invited to offer comments and suggestions reflecting their views of the "management and maintenance" of these recreation areas.

Input was recorded on post it notes and attached to flip charts color coded to provide three ways of offering comments based upon the following three questions:

- √ What is working and should be continued? (KEEP)
- √ What is missing or needs improvement? (IMPROVE)
- √ What needs to stop or change? (CHANGE)

After all input was completed participants were each provided with 5 blue color dots. They were invited to review all comments posted on each of the Gateway Community flip charts and choose their "Top 5" by placing one color dot next to the five ideas that were of greatest importance. The color dots can be seen in the photo at right and also captured in the report pages following.

Some individuals observed at each meeting that their comments properly applied to more than one area or indeed all areas of the Inyo National Forest. The word "universal" was used by several participants and can be found on the pages following.

In some instances comments were offered based upon something missing or needing greater clarity on the map. For this purpose, individuals noted the comment on a post it and also marked on the map directly by using a number or letter code. All post it notes retrieved with these number codes are included on pages following with the number preserved in parentheses at the beginning of the comment.

Gateway communities are presented north to south along the 395 corridor including Lee Vining, June Lake, Mammoth Lakes, Crowley/Tom's Place, Bishop, Big Pine, Independence, Lone Pine, and Olancha. Note: Bishop was addressed at both meetings to reflect its central location in the corridor.
