## Sustainable Recreation / CALREC Vision Key Working Group Awarded USFS Regional Forester's "Partnership of the Year"

Sacramento, Calif., December 14, 2022 – The Leadership Team of the Sustainable Recreation/CALREC Vision Key Working Group (SRCRV) was awarded a Regional Forester's Honor Award for Partnership of the Year from the U.S. Forest Service Pacific Southwest Region in recognition of the Leadership Team's efforts to develop California's Joint Strategy for Sustainable Outdoor Recreation and Wildfire Resilience for California's Wildfire & Forest Resilience Task Force. The Joint Strategy satisfies Key Actions 3.13 and 3.14 of the California Wildfire and Forest Resilience Action Plan. The California Wildfire and Forest Resilience Task Force will publish the Joint Strategy in early 2023.

"In the span of a single year, the SRCRV collaborative team has taken an idea and turned it into the first joint strategy addressing the nexus between forest health and resilience and the public's access to and enjoyment of these (public) lands," wrote Jim Bacon, Director of Public Services of the U.S. Forest Service Pacific Southwest Region. "Overall, this was one of the most well-managed, efficient, and most importantly, inclusive efforts I've been a part of, especially for the pace at which it was conducted. The SRCRV team developed an inclusive approach to creating the Joint Strategy that included targeted organizations representing the universe of outdoor recreation and public land management across the state."

The Joint Strategy provides goals and 31 key actions that address the interconnected nature of forest health, wildfire mitigation and recovery, and public access to sustainable outdoor recreation. The key actions will be implemented by federal, state, regional, and local partners, across jurisdictions and areas of expertise, under the auspices of the California Wildfire and Forest Resilience Task Force.

In the summer of 2021, California's Wildfire & Forest Resilience Task Force tasked CALREC Vision, an effort sponsored by the Mammoth Lakes Trails and Public Access Foundation, to establish, convene, and facilitate a Key Working Group to be co-led by the U.S. Forest Service and the State of California to produce a Joint Strategy for Sustainable Outdoor Recreation in California, which will satisfy Key Actions 3.13 and 3.14 from California's Wildfire & Forest Resilience Action Plan. Publication of the final Joint Strategy document — *California's Joint Strategy for Sustainable Outdoor Recreation and Wildfire Resilience* — is anticipated for early 2023.
